Payment Policies & Release Form

Registration:

A \$40.00 non refundable registration fee is required yearly at time of registration. A \$25 non refundable for those only taking the summer session of that year if not enrolled in the previous fall session.

Tuition:

Must be paid by debit, charge card, or post dated checks and will be debited on the 23rd of each month. Checks should be made payable to TX Academy of Dance & Twirl or TXA! Form of payment must be received upon registration to confirm class time. A \$10.00 service fee will be accessed after the 23rd if payment is not received due to declined or insufficient check OR charge. There is a \$30.00 charge on returned checks. **A \$10.00 late fee will be charged if received after the 28th in addition to the \$10.00 service fee.**

Setting up your term of payment in advance

Cash in advance of 3 months paid every 2 months will be accepted under special circumstances. **We do not except monthly payments in person on a regular basis. Payments must be in advance as mentioned above.**



Withdrawals and Refunds:

In the fall session there is a 2 month minimum for all lessons. One month notice from the 23rd of the month is required to discontinue any classes and only at certain times. Withdrawal must be done in person and will not be accepted over the phone. Withdrawal must be done at the school office and not with the teacher. Payee also agrees that withdrawals will not be accepted between Feb. 23rd and June 23rd in the Fall Session, and between June 23rd and Aug. 23rd in the Summer Session. Payees also agrees that if they are on a team or taking a private lesson that after registering for the new year in May that there are no withdraws for the Summer and Fall Session which are considered one for team because they are year round. Payee also agrees that whether the student decides to attend or not that this contract is still in effect and all payments will be due and monthly payments will be debited as usual.

To withdrawal from a class a parent or adult student must:

1. Inform the school administration in person, and
2. Complete and sign a withdrawal form provided by the school office
3. Give the proper notice for the fall and summer sessions as stated above and in our handbook.

No refunds will be given for tuition, costumes, merchandise, fundraising, and is considered property of TXA.

TX Academy of Dance & Twirl reserves the right to terminate lessons to any students without notice.

Payment by Charge Card Agreement

The person paying for the student's tuition is referred to as the payee and the word term refers to the date in which the student begins (registration day) and ends.
